

# ADDITIONAL CLARITY 03/12/2024

# **Meeting Summary** Pattern for Progress

**Hudson Valley Pattern for Progress** recently joined the chamber's government affairs committee to discuss its latest report, Childcare in the Hudson Valley, which examines the state of childcare throughout the region. Pattern CEO Adam Bosch shared data about the deepening scarcity of childcare throughout the Hudson Valley, along with demographic, economic, and public policy factors that are causing many childcare businesses to close.

The number of licensed childcare providers in the Hudson Valley has dropped by 27% over the past 15 years, including a loss of 38% of licensed childcare providers in Orange County. Those childcare businesses that remain are feeling the financial pinch from a steadily declining youth population in the region; onerous regulations; challenges related to recruiting and retaining childcare workers; and the state's universal pre-K program, which resulted in thousands of 4-year-old children (and the revenue they brought) leaving the childcare system.

This is a complex issue that affects the early education of our children. It also affects workforce participation, especially among working mothers. In a recent survey of businesses in the Hudson Valley, 41 percent ranked childcare as the top support they needed for their employees but could not provide. Childcare surpassed transportation as the top answer for employers. Many businesses also told Pattern that they had lost employees, or were turned down by job candidates, because of the high cost of childcare or its lack of availability. As part of our ongoing mission to support businesses in Orange County, we know that viable answers to the childcare shortage will be important to supporting our workforce and our families in the future.

### **New Credit Card Surcharge Guidelines Begin** Sunday, February 11

The NYS Department of State Division of Consumer Protection has issued new guidance regarding credit card surcharges including guidance on how these fees are communication to your customers.

What does this mean for New Yorkers? A business has the option of passing along the actual cost of credit card processing fees as a surcharge to customers, but they must be transparent by displaying the highest total price (excluding sales tax). A sign stating only the credit card surcharge fee will no
